Review date:-Risk assessment reviewed in line with operations and outages. This assessment includes the temporary buildings situated in the Electric Mountain car park, where the tour begins and ends due to the refurbishment work of the visitor centre.

Comments/Additional Information:-

This Risk Assessment covers the area of the plant and Viewing Gallery at Dinorwig that forms the Electric Mountain visitor route. The tour is now managed using smaller mini buses and one person acting as a driver/guide. The tour party no longer walk up the stairs from the MIV to the Pump Turbine, but are now driven in the mini bus to each location. The final risk rating is 6 which is classed as a low risk.
